

**ORDER NR. 134/92
of May 20 ***

Pursuant to article 27 of Decree-Law nr. 96/89, of March 28, and with the objective of establishing the fees for the registration and other services to be provided by the International Shipping Register - MAR.

The Regional Government of Madeira, pursuant to article 7 (2) of Regional Decree nr. 2/76, of November 11, approves the following:

1- For the initial registration or renewal of the registration of a ship, the following fees are due:

- a) A fixed fee in the amount of 1.800 euros;
- b) A variable fee:

From 2500 NT	up to 10000 NT	0,70 euros per NT
From 10000 NT	up to 20000 NT	0,50 euros per NT
From 20000 NT	up to 30000 NT	0,30 euros per NT
Above 30000 NT		0,10 euros per NT

NT = Net tonnage

2- As annual maintenance fee, the following amounts are due:

- a) A fixed fee in the amount of 1.400 euros;
- b) A variable fee:

SCALE	FEE PER SCALE
Up to 250 NT	200 euros
From 250 NT up to 2500 NT	0,80 euros por NT
From 2500 NT up to 20000 NT	0,40 euros por NT
Above 20000 NT	0,25 euros por NT

NT = Net tonnage

- c) Ships falling under the provisions of nr.1 of article 20 of Decree-Law 96/89, of March 28, and which registration has been transferred from the traditional registry are exempt from the fees foreseen in the preceding paragraph, the following variable fees being applicable:

SCALE	FEE PER SCALE
Up to 250 NT	200 euros
From 250 NT up to 2500 NT	0,40 euros per NT
From 2500 NT up to 20000 NT	0,25 euros per NT
Above 20000 NT	0,15 euros per NT

NT = Net tonnage

- d) This fee is payable at the beginning of each 12-month period, such payment being due on the first day of the month preceding the due date.
- 2A-
- a) For the registration of a new commercial ship, the fees foreseen in the preceding paragraphs may benefit from the reductions foreseen in paragraph b) of this number, provided that on the date of the new registration:
 - i. The applicant is also the owner of other commercial ships registered in MAR.
 - ii. Such registrations are valid and in force.
 - b) The fees due according to the terms of paragraph a) may benefit from one of the following reductions:
 - i. 10% over the initial fee, when due by the owner of two previous registrations;
 - ii. 15% over the amount of the initial and annual fees, referring to the first and subsequent years, when due by the owner of four previous registrations;
 - iii. 20% over the amount of the initial and annual fees, referring to the first and subsequent years, when due by the owner of nine previous registrations;
 - iv. 50% over the amount of the initial fee and 20% over the amount of the annual fees, referring to the first and subsequent years, when due by the owner of fourteen previous registrations;
 - v. The fee for the initial registration shall be reduced to 1 euro when due by the owner of thirty previous registrations;
 - vi. 50% over the amount of the annual fees, referring to the first and subsequent years, when due by the owner of thirty previous registrations.
 - c) The concessionaire may request from the owner of the ship the necessary documents to evidence the requirements of sub-paragraphs (i) and (ii) of paragraph a), being the approval of the referred reductions subject to the presentation of such documents:
- 3- The fee due for passenger ships, platforms and other ancillary ships other than tug boats is the one established in numbers 1 and 2 of this Order, increased of 15% in relation to number 1 and of 30% in relation to number 2.
- 4- For the definition of the capacity and issuance of the respective certificate, a 300 euros fee shall apply.
- 5- For each inspection carried out, upon the request or in the interest of the owner of the ship or for purposes of MAR annual inspection, a 100 euros/hour shall apply.
- 6- The amounts established in the preceding number shall be added of the transportation and lodging costs of the expert(s) undertaking the inspection.
- Whenever inspections and verifications cannot be performed due to delays of the ship or any other circumstances not attributable to the Registry, the respective expenses shall be borne by the owner of the ship
- 7- For the issue, revalidation, or additional notes on the certificates, declarations and other documents of the ship, a fee of 130 euros shall apply per certificate, declaration or document.

- 8- For the issue or recognition of each certificate of officials, crew members or navy-art categories, a fee of 100 euros shall apply in relation to officials and of 25 euros for the remaining categories.
- 9- For the boarding of each crew member a fee of 20 euros shall apply.
- 10-The Technical Commission of MAR shall establish by publication the amount of the fees due for the provision of official forms, on board record books and other inherent services.
- 11-The procedures to obtain the ship radio station license is subject to a fee of 500 euros.
- 12-Cancellation of the registration of a ship is subject to a fee of 650 euros.
- 13-Each of the following events is subject to a fee of 300 euros:
 - a) Recognition, acquisition of the ownership title or change of owner;
 - b) Bareboat chartering contract as well as any alterations to the contract, namely addenda and prorogations;
 - c) Change of the name of the ship;
 - d) Inscription of the initial registration;
 - e) Recognition, establishment, acquisition, modification or extinction of usufruct rights;
 - f) Construction contracts;
 - g) Mortgages, modifications thereto, extinction, transfer or assignment of the mortgage credits, or of the respective ranking in registration.
- 14-The amounts referred to in the preceding numbers shall be paid to the Government of the Autonomous Region of Madeira by means of deposit in favor of the concessionaire of the Free Trade Zone of Madeira, prior to the issue of the registration documents, and the respective receipts shall be attached to the registration procedure documentation.
- 15-Any omission of the present Order shall be object of an Order of the Regional Government, issued upon the proposal of the Technical Commission.
- 16-This present Order revokes Order nr. 134/89, of September 28;
- 17-The present Order shall become effective immediately.
